COMPOSITION

100g product contains:

Pure Permethrin (25/75 cis/trans) 0.15 g (1.5 g/l)

Pure Tetramethrin 0.06 g (0.6 g/l)

Pure Piperonyl butoxide 0.30 g (3.0 g/l)

Cofomulants and water q.s. for 100g

DOSAGE AND USE

The product is ready-to-use and must be sprayed by means of normal hand operated or motor driven sprinklers, spraying over the surfaces at the ratio of 1 litre per 100-150 sqm. Shake before using.

Bed bugs control: apply the product as it is over the areas (walls, corners) near the infested armchairs or beds. Before the treatment, move all sheets and blankets away and apply on mattresses and on the other infested furnishings, bed and armchair frames, etc. Do not apply on materials and fabrics that are in direct contact with humans. If necessary, repeat the treatment according to the infesting insect, of its development cycle and environmental conditions.

To avoid risks to man and the environment, comply with the instructions for use.
