COMPOSITION

100 g product contains:

Pure Pyrethrins	0.30 g (3.0 g/l) (equal to 0.60 g pyrethrum extract 50%)
Pure Piperonyl butoxide	3.00 g (30.0 g/l)
Co-formulants	q.s. for 100 g

DOSAGE AND USE

PIRETROX™ PU is used as such at the ratio 1 litre every 100-150 sqm of area and can be used by means of the common sprayers, manual pressure pumps. Shake before use.

Flying insects: Indoor use: spray over surfaces (walls, planes, shutters, etc). Outdoor use: spray over the building outer walls, etc. Against the wasps, apply directly on the nest, preferably early morning.

Crawling insects: Indoor use: spray over surfaces, cracks, skirting boards, etc. Outdoor use: spray the most suitable dosage over the building outer walls, etc.

To avoid risks to man and the environment, comply with the instructions for use.
